The implementation of these orders depends, first of all, on the correct conclusion of their struggle with the enemy forces"(1).

Zakariyo ar-Razi said that in various aspects of life, a teacher is a person who is kind and caring to the student, because he promotes the main human qualities - purity, goodness, chastity, humanity, etc. to the students. Paying special attention to issues of moral and spiritual education, he gave useful and valuable advice to overcome difficulties in people's lives. In the process of education and upbringing, the thinker puts common sense first, and then evaluates all human actions based on his own reason and wisdom. He gives recommendations to teachers and coaches on how not to get bored and bother young people in the way of learning.

The thinker emphasizes that education of the young generation is one of the most important tasks of teachers. A teacher should use all his knowledge and skills in teaching and educating young people. He regularly talks with students, reveals their shortcomings and undesirable qualities, and shows ways to eliminate them. According to the thinker, the teacher should have sufficient knowledge and education and should not interfere in the work of upbringing and education, should always take into account the psychological aspects of the student and treat him well. As a close and friendly person, the teacher should be regularly aware of the student's life situation. According to his opinions and recommendations, people should be kind to each other, have special grace and compassion.
